1.1. Product Description: Tarkett 959 adhesive is a solvent-free easy to apply adhesive specifically formulated for installing Access, Aloft Glue Down, Azterra, Color Essence, Color Essence SR, Cortina, Grande SR, Crossroads, FiberFloor, Gemstone, ID Freedom, ID Inspiration, Maintstreet Carpet Tile, Contour LVT, Event LVT, Venue LVT, Collections Infinies/Riot/Alphabet LVT, Indigenous Earth LVT, and More Than Wood LVT, Origins, Performa, PermaStone, SureStart Underlayment, TruTex, Vinyl Sheet (Felt) and Vista.

#### 1.3 Physical Characteristics:

- Base Acrylic
- Color White
- Shelf Life 2 year in unused, properly stored container
- Freeze thaw Protect from freezing, do not freeze
- Working Time Up to 2 hours
- Contains no hazardous or carcinogenic ingredients as defined by OSHA chemicals and meets all federal, state and local air quality regulations.

### 1.4 Adhesive Coverage:

All Flooring types listed above.

Porous: 1/16" x 1/16" v – notch trowel not to exceed 150 – 175 sq. ft. per gallon Non-Porous: 1/16" x 1/32" x 1/32" U – notch trowel

not to exceed 250 – 300 sq. ft. per gallon

#### 2. SUBSTRATE PREPARATION

NOTE: A clean substrate is essential! Suitable substrates include on, below, or above grade concrete (within moisture and alkalinity specifications) and APA underlayment grade plywood. All substrates must be clean, structurally sound, smooth, dry and free of waxes, existing adhesives, dirt, dust, grease, oil and paint, curing compounds or sealers. This adhesive cannot be used over chemically cleaned substrates. All concrete substrates, preparation and testing procedures must conform to appropriate ASTM F710 guidelines. Tarkett 959 Vinyl Tile and Plank adhesive may be used for installations over concrete substrates with up to 90% RH per latest version of ASTM F2170 and 8lbs per 1000 sf/24hrs per the latest version of ASTM F1869 and pH between 7.0 – 10.0.

The interior air temperature and Relative Humidity must be maintained between 65 - 85°F and 40-60% RH, and the substrate temperature should be at least 5 degrees F. higher than the Dew Point.

#### 3. AVAILABILITY AND COST

Available through authorized Tarkett distributors nationwide.

#### 4. Traffic:

All traffic must be restricted for a minimum of 24 hours after installation. Restrict heavy traffic, rolling loads, or furniture placement for 72 hours after installation.

Wait at least 48 hours before beginning initial maintenance.
