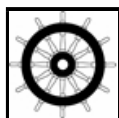

Composed of polyvinyl chloride, mineral fillers (33%), homogenous filled plasticized PVC, pigment, stabilizer and IQ PUR.

Max. thickness: 2 mm

Low flame spread surface material, not generating excessive quantities of smoke nor toxic products in fire.

Approved for use as floor coverings on any low flame-spread floor covering, steel or non-combustible material.

Approved for all colours.

Maximum organic content: 39 %

Approved for use as floor covering on any low flame-spread floor covering, steel or non-combustible material

Any adhesive used, other than the one used during testing, has to be tested for low flame spread characteristics according to IMO 2010 FTP Code part 5 and to be approved according to the Marine Equipment Directive and bear the MED Mark of Conformity.

Several layers of floor coverings are acceptable provided that each layer is approved according to the Marine Equipment Directive and bear the MED Mark of Conformity.
