

# iQ Granit / iQ Eminent

The selected homogeneous flooring similar to iQ Granit/iQ Eminent belongs to the compact vinyl floors category under the ISO standard 15081, available in 2m wide sheet and 61x61 tiles, with a binder content of Type I and a thickness of 2 mm. The product is a pressed homogeneous vinyl flooring.

iQ Granit/iQ Eminent enables dry buffing to restore the surface without any need of chemicals (no wax, no polish for life) and is also easily repairable avoiding replacement when the surface is damaged.

The product offers an excellent cleanability proven by Fraunhofer (Riboflavin test) and is resistant to disinfectants and antiseptics used in healthcare settings. It doesn't favour bacteria growth (according to ISO 846/C). The product can be installed in the most demanding environments such as ISO 4 cleanrooms (ISO14644-1).

iQ Granit is available in compact and acoustic versions. The acoustic version increases underfoot comfort and greatly reduces sound transmission by 15dB.

Welding rods are available in matching colours coordinated with flooring pattern designs to ensure a perfect finish. The products are also equipped with multicolour welding rods to ensure seamless finish.

iQ Granit/iQ Eminent comes with a 10 Year Warranty.

#### **HEALTHY MATERIAL**

Very low emissions of VOCs (Volatile Organic Compounds), <10µg/m³, tested 28 days after installation, a threshold 100 times lower than levels set by the most stringent EU regulations. It is free of formaldehyde.

### The product formulation does not contain phthalate based plasticiser. It doesn't contain any biocide.

The selected flooring is covered by a third-party verified ingredient disclosure and material risk declaration down to 0.01%, thus ensuring compliance far beyond REACH regulation requirements, such as Material Health Statement (MHS) delivered by Environmental Protection Encouragement Agency (EPEA).
